#### **1.Registration Confirmation for First-Year Students**

1.1 Students in their first semester are required to submit a registration confirmation twice per semester, no later than the 15th of the month (WS: September & November, SS: February & April). This confirmation must be currently issued by the program management. Any other form of confirmation will not be accepted.

1.2 Failure to submit a registration confirmation will automatically result in the termination of membership.

#### 2. Submission Deadlines for Registration Confirmation

2.1 Registration confirmation must be submitted by September 1st for the winter semester and by February 15th for the summer semester.

#### 3. Dropping Out of Studies & Completion of Studies

3.1 In the event of dropping out of studies or completing studies, students are required to inform ÖHFHWN immediately.

3.2 Upon successful completion of the studies, the membership terminates automatically. Therefore, students must inform the ÖHFHWN about it.

3.3 Failure to notify ÖHFHWN will result in students having to repay the portion of the contribution (€9 per month) that ÖHFHWN pays for membership.

#### 5. Automatic Summer Break and Extension

5.1 Membership will automatically be paused during the summer break (July and August).

5.2 If an extension of membership is needed during the summer break, it must be requested.

#### 6. Termination of Membership

6.1 Termination of membership is only possible monthly through ÖHFHWN.

6.2 Cancellations must be communicated in writing at least one month in advance.

#### 7. Confidentiality of Code

7.1 The membership code must not be shared with third parties.

7.2 CleverFit reserves the right to monitor the use of the code. This code serves solely as a registration code to inform CleverFit that students receive membership as part of our cooperation. The aim is to ensure that only eligible students can access it.

#### 8. Fraud Prevention

8.1 Students are required to adhere to the specified guidelines to prevent fraud.

#### **Privacy Policy**

Personal data will be stored for as long as students have a membership at CleverFit through ÖHFHWN. Once the membership is terminated, the data will be promptly deleted. This data is used to register students at CleverFit and is used by ÖHFHWN for verification purposes regarding continuous enrollment at FH Wiener Neustadt.
