Agreement Policies

1.Registration Confirmation

- 1.1 Students are required to submit the enrollment certificate for the current semester along with this contract.
- 1.2 Failure to submit the enrollment certificate will result in an incomplete registration, and the application will not be processed.
- 1.3 At the start of a new semester, students are required to independently submit the current enrollment certificate to the ÖH FHWN.

2. Dropping Out of Studies & Completion of Studies

- 2.1 In the event of withdrawal from studies or successful graduation, students are required to inform the ÖH FHWN immediately.
- 2.2 Upon successful graduation, the membership will automatically terminate. Therefore, students must inform the ÖH FHWN of their graduation.
- 2.3 Failure to notify the ÖH FHWN will result in the students being required to repay the portion of the membership fee (€9 per month) that the ÖH FHWN covers.

3. Termination of Membership

- 3.1 Termination of membership is only possible through the ÖH FHWN after a minimum membership period of 6 months.
- 3.2 Terminations must be communicated in writing at least one month in advance.

4. Confidentiality of Code

- 4.1 The membership code must not be shared with third parties.
- 4.2 CleverFit reserves the right to monitor the use of the code. This code serves solely as a registration code to inform CleverFit that students are receiving membership under our cooperation agreement. The goal is to ensure that only eligible students have access to it.

5. Fraud Prevention

5.1 Students are required to adhere to the specified guidelines to prevent fraud.

Privacy Policy

Personal data will be stored for as long as students have a membership at CleverFit through ÖHFHWN. Once the membership is terminated, the data will be promptly deleted.
